The M-119 Tunnel of Trees Corridor is designated as a Scenic Heritage Route because of its natural beauty and the community's commitment to its integrity. The Implementation Committee seeks to educate the community on how to protect and maintain those characteristics. Through the development of the Management Plan, the Committee worked to synthesize the concerted efforts of community members who had worked to protect the corridor for the past 30 years. Designation as a Heritage Route enhances a community's opportunity to work closely with the Michigan Department of Transportation and the County Road Commission to create or maintain a corridor that fits with the community's vision.

About the M-119 “Tunnel of Trees”

The M-119 Tunnel of Trees Heritage Route winds for 20 miles through the townships of West Traverse, Friendship, Readmond, and Cross Village. M-119 is renowned for its riveting fall colors and its exhilarating views of Lake Michigan.

Northern Michigan’s popularity as a tourist location has contributed to the road’s use, not only as a route, but as a destination for travelers. With the increase in M-119’s popularity reflected by the steady increase in both seasonal and permanent populations, environmental, transportation and land use management issues have gained the increased attention of local officials and residents. It is for these reasons that a group of local citizens initially came together to discuss the future of the M-119 corridor.

In June 2001, the M-119 Heritage Route Committee was formed to develop the *M-119 Heritage Route Management Plan*. The Networks Northwest staff members worked with a dedicated group of representatives from Cross Village, Friendship, and Readmond Townships and the Emmet County Lakeshore Association to develop the Management Plan. The Heritage Route Plan Committee met monthly to gather and review data and maps, and to draft and finalize the management plan. The plan inventories the unique qualities of the roadway and outlines a process for preserving and enhancing the special character of the area. This document describes goals, strategies, and recommendations to promote preservation, maintenance and design, and safety. The M-119 Tunnel of Trees Scenic Heritage Route was officially designated by the State of Michigan in 2003. West Traverse Township was added in 2007.

What is a Heritage Route?

In 1993, the Michigan Heritage Route Program was created by Public Act 69 of 1993, giving the State of Michigan the authority to designate heritage routes. Under the Heritage Route Program administered by the Michigan Department of Transportation, local communities have the opportunity to apply to have routes designated under one of three categories: scenic, recreation, or historic. Essentially, route designation enables local communities to preserve and enjoy the corridor.

The Heritage Route Program is designed to identify, inventory, protect, enhance, and in some cases, promote state trunk lines and adjacent land with distinctive or unique scenic, cultural, or historic qualities.



Goals of the M-119 Tunnel Of Trees Scenic Heritage Route Committee

The Committee is dedicated to preserving and enhancing the scenic, cultural, natural, and historic characteristics of the M-119 Corridor.

- **Promote Preservation and Conservation of the Tunnel of Trees for Balanced Growth and Development.**

Future land use along the corridor will be influenced by a variety of factors: individual land owners’ decisions, regulations administered by the County (Emmet County) and the local units of government (West Traverse Township), state legislation, the state of the economy, land costs, and pressures resulting from changing demographics and recreational and travel patterns.

- **Balancing Roadside Safety with Aesthetics**

Safety is of primary importance along the roadway. Preserving and protecting the natural, cultural, and scenic character of the corridor is an equally important goal.

- **Promote Wise Land Use Development**

Residents along the corridor have continued to express concern regarding development along the Lake Michigan shoreline. The M-119 Management Plan supports efforts to minimize the disruption of steep slopes that could damage the integrity of the roadway and undermine the safety and character of the corridor.

- **Prevent Intrusions to Scenic Character**

Intrusions to the scenic character include any built structure, landscape elements such as lighting, fencing, signage, and utilities that contrast with the scenic and natural character of the corridor. The plan advocates the use of natural materials for built structures, as well as the use of outdoor lighting that does not detract from the night sky.

- **Promote Appropriate Use of the Corridor and Alternative Routes**

The curves, narrow roadbed, and the Tunnel of Trees render M-119 as a road less traveled, a characteristic that local communities would like to continue.
