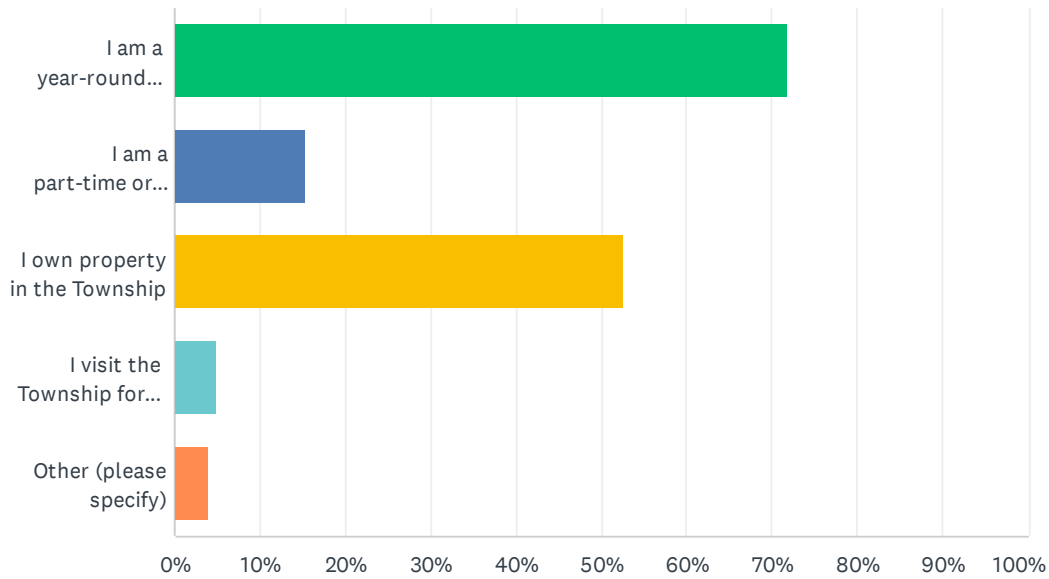

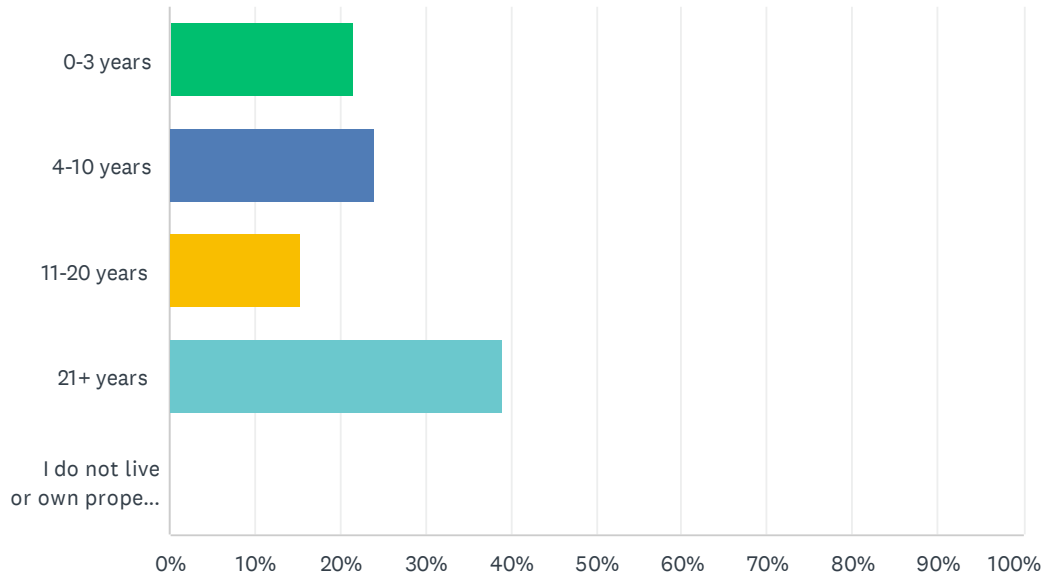

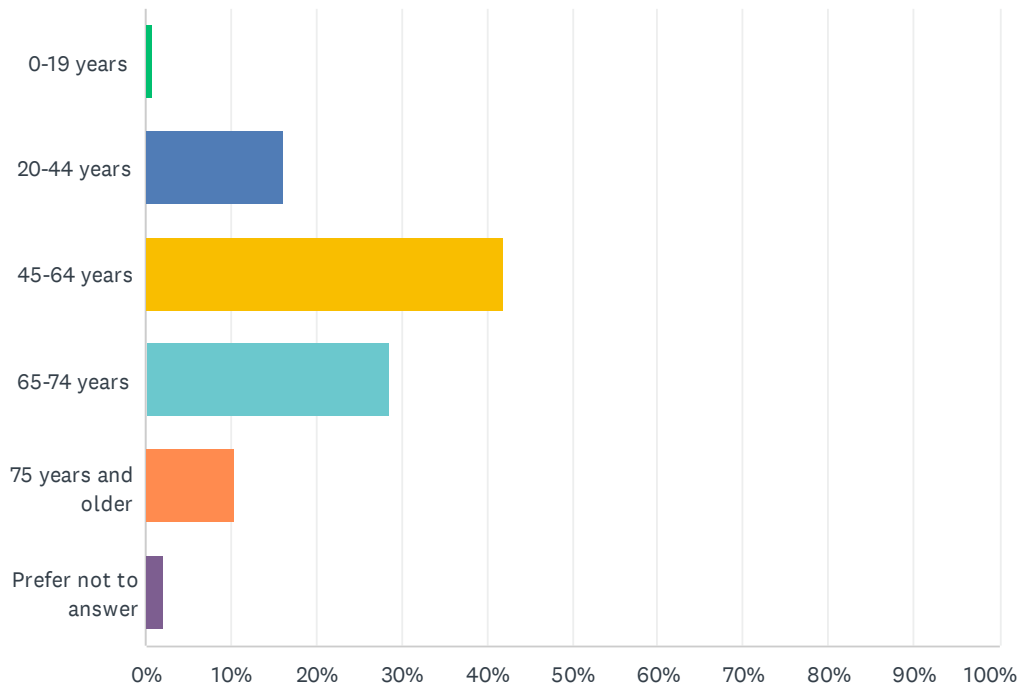

Q3 Select your age group.

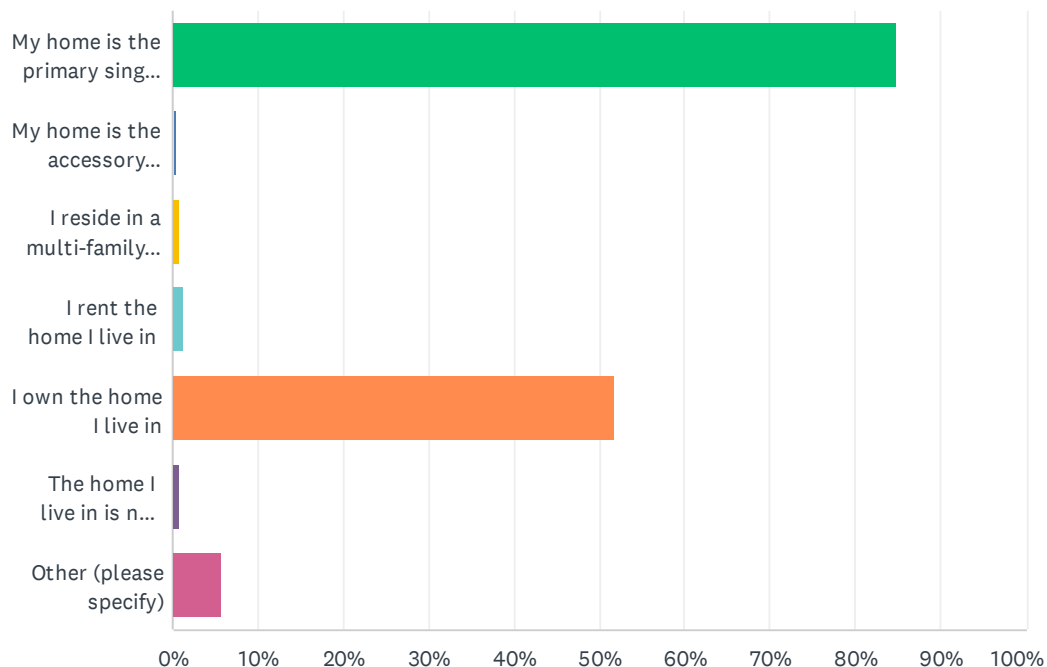

Q6 How does each of the following influence your decision to live in Bingham Township? Select the option that best applies to you.

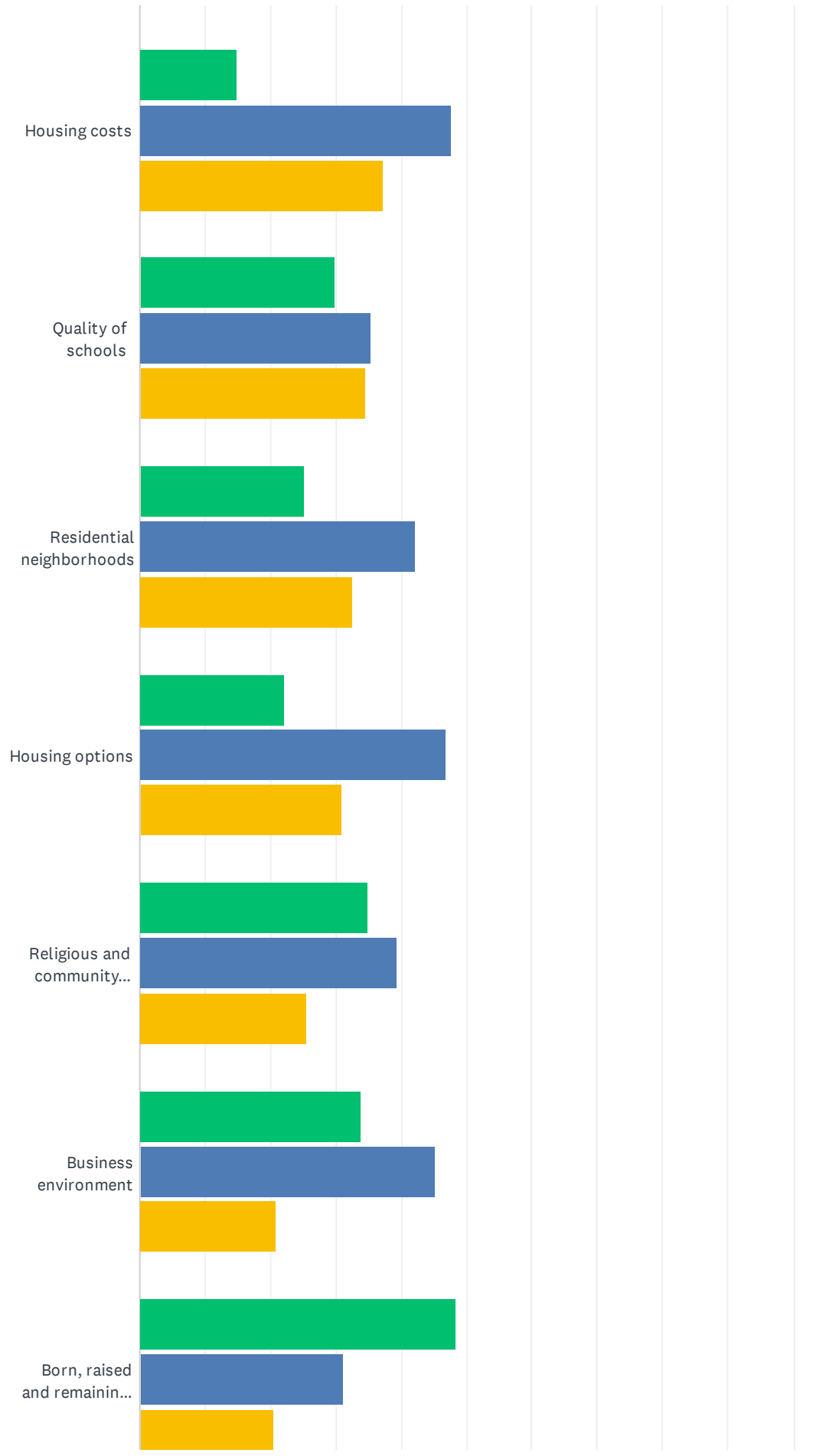

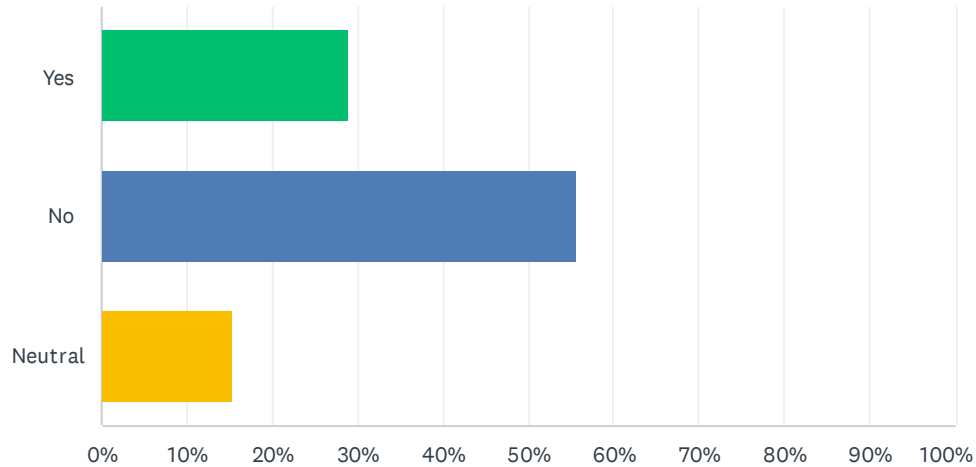

Q16 Do you support the placement of commercial/industrial-scale wind turbine facilities in Bingham Township for renewable energy production?

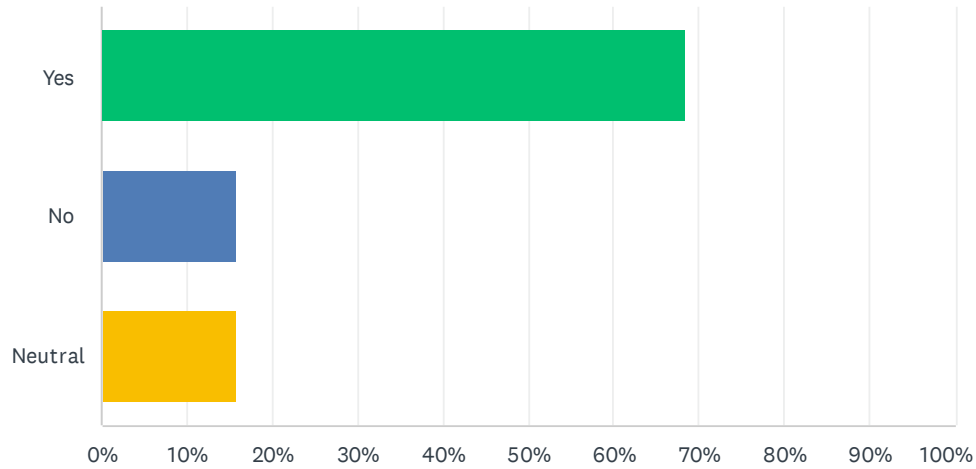

Q17 Do you support residential-scale solar arrays for personal home renewable energy production in Bingham Township?

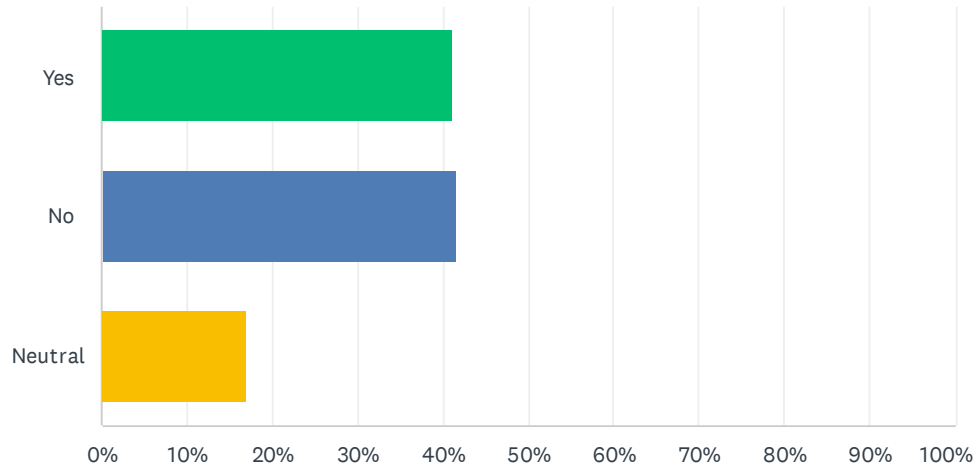

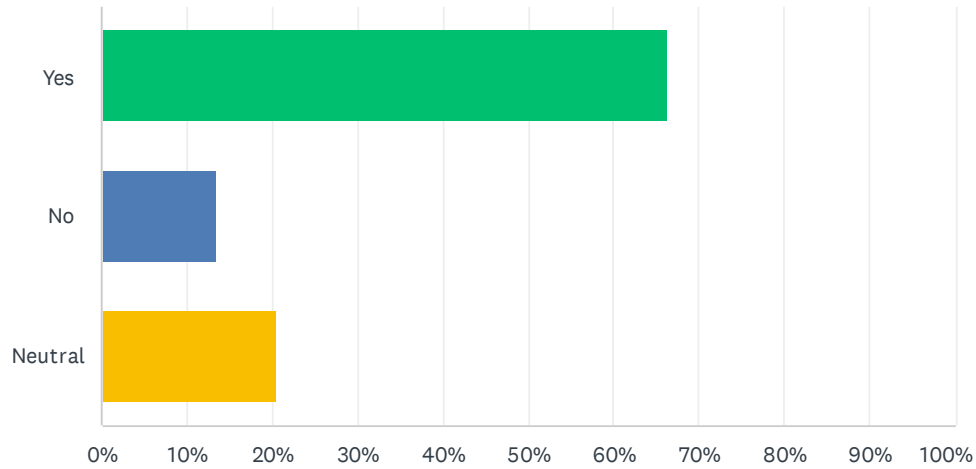

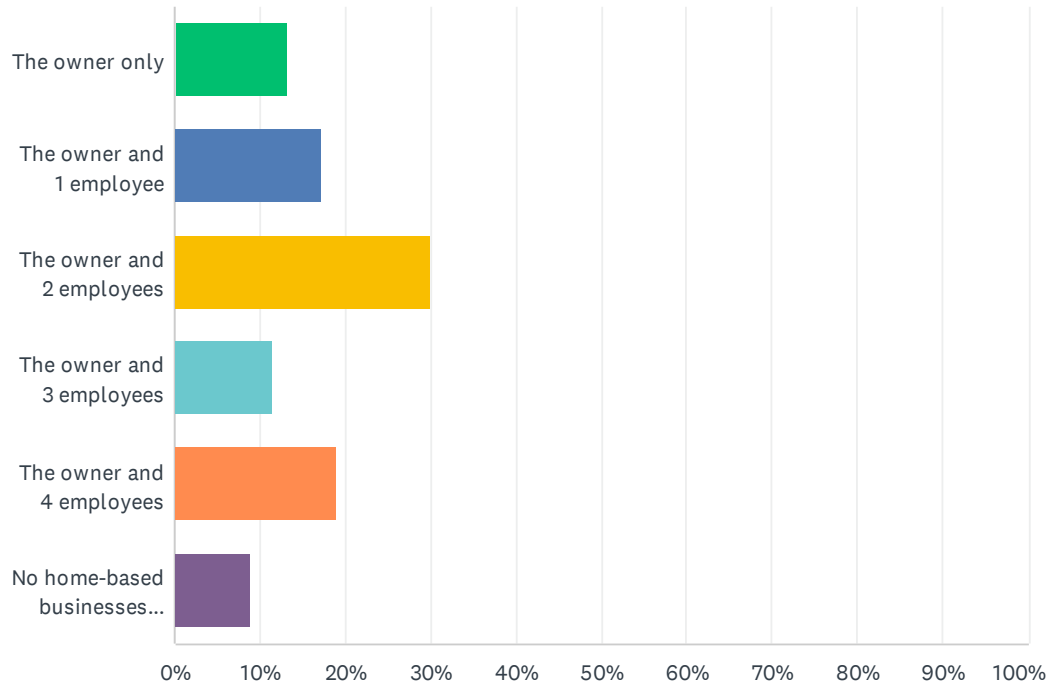

Q21 How many employees do you feel a home-based business should be limited to?

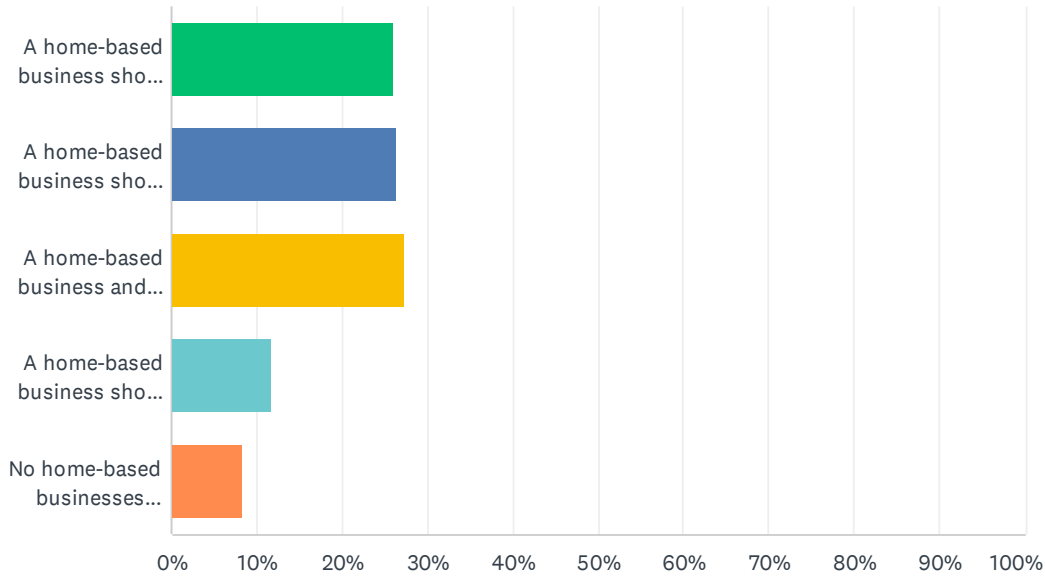

Q22 Please select the confines of a home-based business that you agree with most?

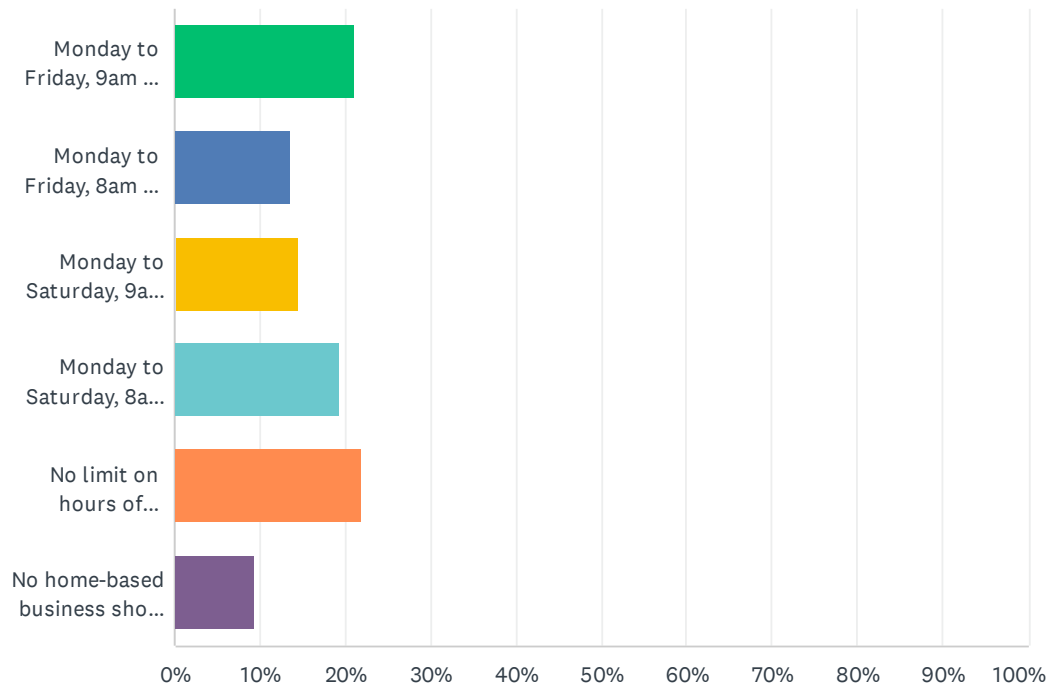

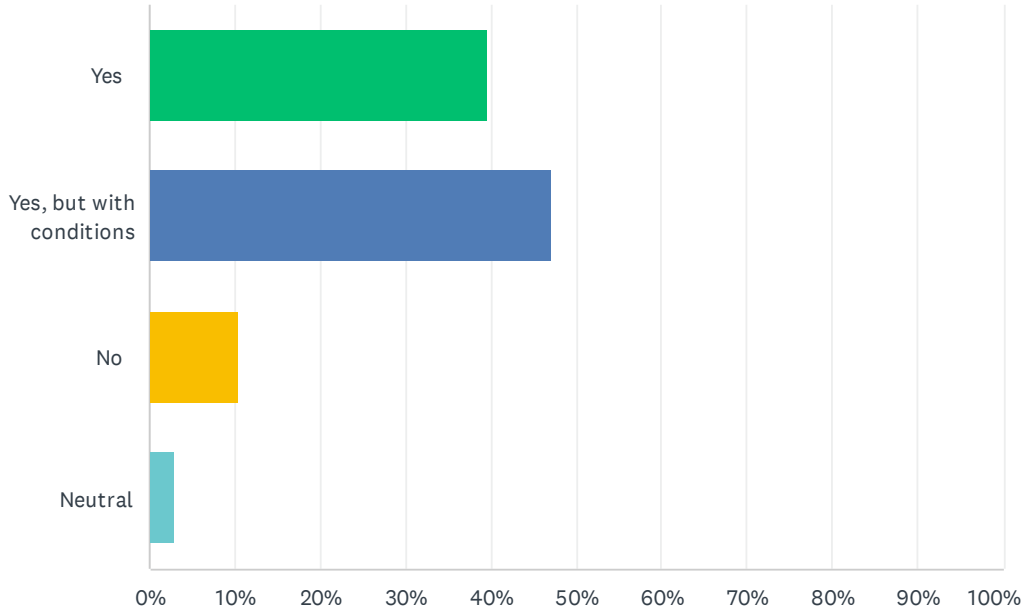

Q24 Do you support bed and breakfast operations within Bingham Township?

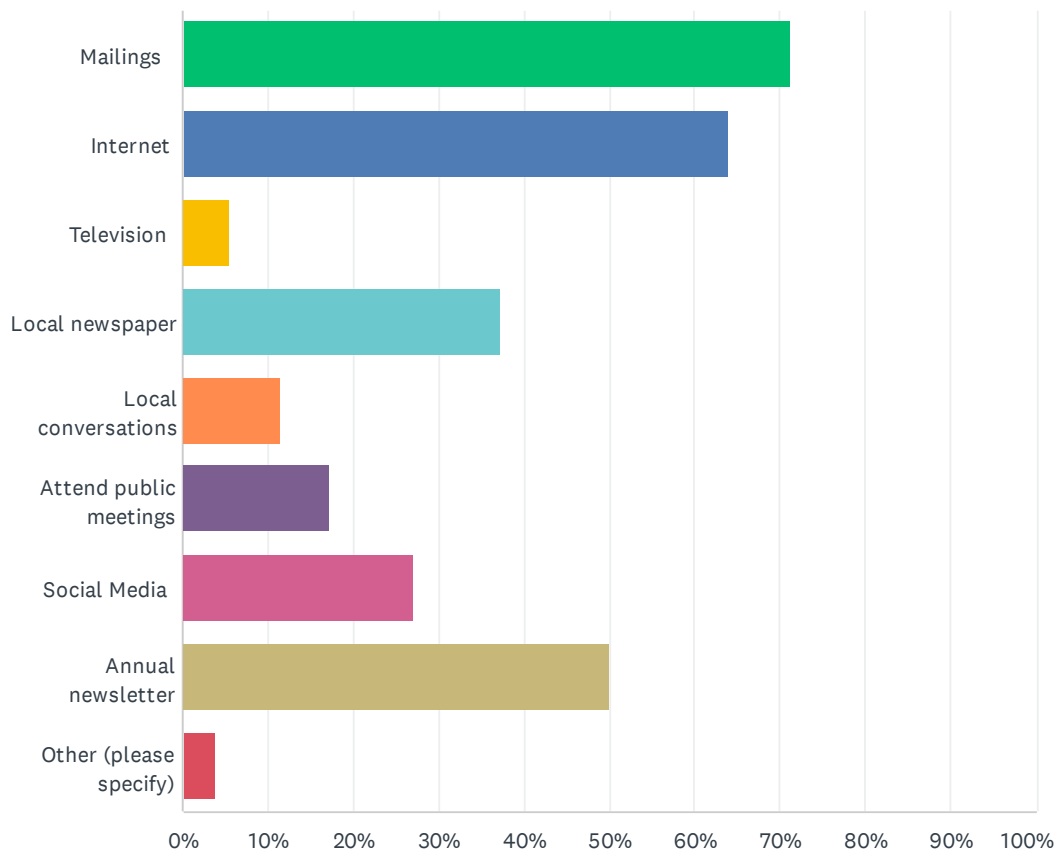

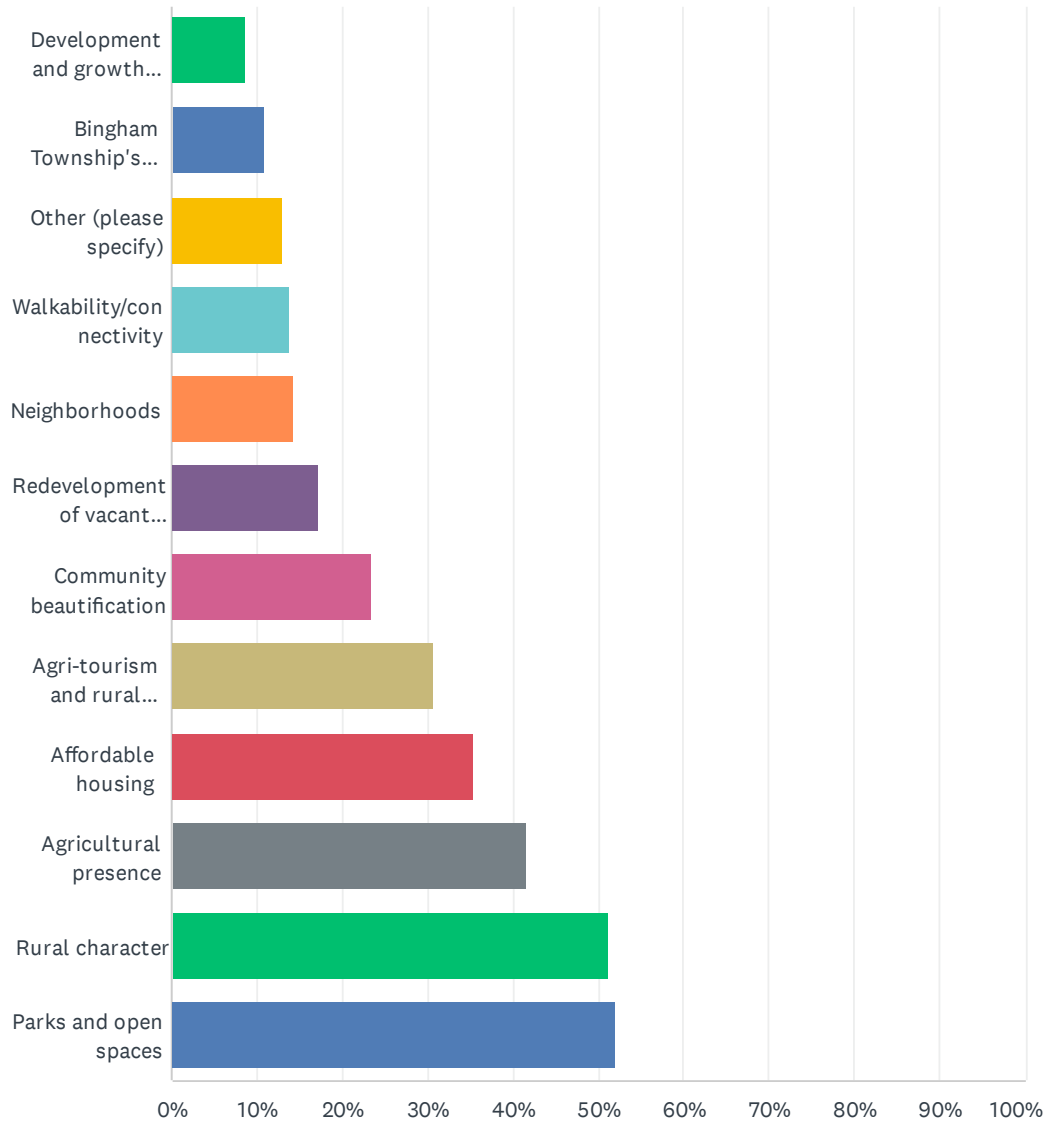
