## I. Introductions

Rollcall initiated by Isha Pithwa (Networks Northwest), with introductions noted as attendance: Julie Stec (Manistee County Transportation, Inc.), Brad Kluczynski (Manistee County Road Commission)

# II. Agenda

## III. Discussion on agreements

The Manistee County Road Commission (MCRC) expressed interest in collaborating with other counties within Rural Task Force 10B, specifically Missaukee and Wexford, regarding fund allocation agreements.

MCRC and the Manistee County Transportation Authority (MCT) proposed a new agreement that allocates 15% of funds to MCT in alternating years moving forward.

Motion to approve this agreement between the Manistee County Road Commission and Manistee County Transportation Authority, allocating 15% to MCT every other year, was made by Brad Kluczynski and supported by Julie Stec. The motion was unanimously approved.

River Rd – JN 215154 – resurface project – need new 1799 form for this change of budget/funds, STP - \$683,762 (none from State D)

# V. FY 2026

MCRC:

South Shore Rd – JN 215159 – Crush and shape – need new 1799 form for this project – STP - \$698,000 and State D - \$257,910

#### VI. **FY2027**

#### MCRC:

Countywide Chip Seal – New Project - Chip Seal (preventative maintenance) – need new 1799 form for this project – STP - \$713,000 and State D - \$122,023. Note – roads are not selected and will be updated later as the year gets close.

## VII. FY2028

Transit:

New project (bus purchase?) – need 1797 form for this project – STP - \$110,000

MCRC:

Countywide Chip Seal – New Project/continuation - Chip Seal (preventative maintenance) – need new 1799 form for this project – STP - \$618,000 and State D - \$122,023

## VIII. FY2029

MCRC:

Healey Lake Rd - South of 13 mile and north of 9 mile – New Project – Overlay Preventative Maintenance - need new 1799 form for this project – STP - \$743,000 and State D - \$122,023.

Local Match not stated at present for any years.
